Description: How can state and federal policy most help institutions and systems bring guided pathways to scale and improve student success? Institutional and systems-level practitioners have been meeting over the past couple of years to identify what good policy looks like. With the support of Jobs for the Future (JFF) and an array of national advisors, the group of practitioners, known as the Policy Leadership Trust for Student Success, have crafted a State Policy Framework that reflects their collective vision for pathways-friendly policies informed by, and supportive of, good practice. In this session, members of the Trust, together with JFF, will present the framework for discussion. Drawing on major themes from the pre-institute policy exercise, panelists will lead a conversation on how practitioners can advocate for good policy.

Description: One of the greatest promises of pathways reforms is to close equity gaps for students of color, those from low-income backgrounds, and others who have been historically underserved by community colleges. As teams work to implement pathways reforms, it is essential to monitor equity gaps and course-correct where gaps are not being addressed or widening. This session will provide a framework for assessing and responding to equity gaps and setting equity goals relevant to pathways reforms, as well as making the case for sustained pursuit of equity goals. In addition to disaggregated success data for progression and completion, the framework covers access to particular programs of study and high-impact practices, as well as students' post-graduation success in transfer and labor markets.

3. What Good Policy Looks Like: Advancing Practitioner-Informed Policy Through the Policy Leadership Trust's State Policy Framework

Institutional changes that are needed to support a more holistic approach to student aid will be highlighted.
