Re: Letter of Reference for Atlantic Cape Community College President Barbara Gaba

It is my distinct pleasure to write a letter of reference on behalf of Dr. Barbara Gaba, president of Atlantic Cape Community College, to support her nomination to the AACC Board of Directors. Having been her colleague for more than six years at Union County College, I know Dr. Gaba to be a talented, forward-thinking, and dedicated college leader who will continue to be a powerful advocate for community colleges.

In her role prior to becoming Atlantic Cape's first African-American female president, Dr. Gaba served with distinction as provost of the Union County College's Elizabeth Campus and forged strong partnerships with elected officials, community leaders, and students in New Jersey's fourth largest city. Moreover, she was actively engaged in all aspects of managing a comprehensive community college within her purview as Campus provost. In 2016, when Union County College earned its decennial accreditation with distinction, Dr. Gaba was solely responsible for successfully ensuring that all of the conditions of federal compliance were met.

Dr. Gaba is a credit to the field of higher education; her vision and dedication, together with her kind and generous nature, would make her a valued member of the AACC Board.
